

Terms of use of Kranstolppa

Kranstolpantie 225, FI-33980 Pirkkala.

The Kranstolppa sauna is rented out to associations and companies. It's not rented out to private individuals.

Registered organisations based in Pirkkala are not charged rent for time slots that they reserve for their regular operations. The price list and additional information: <https://www.pirkkala.fi/toimipisteet/kranstolppa-beach-sauna>

Rental period 1 May–30 September

Camping in the area is subject to separate agreement. There is a small area to sleep on the loft of the sauna.

Rental period 1 October–30 April

The Kranstolppa sauna can be rented during the winter season only between 8:00 and 22:00. Overnight reservations for the sauna are not accepted in the winter season.

Keys

Pick up the key to the sauna from Pirkkala vapaa-aikakeskus leisure centre. The key provides access to the sauna building. There you'll find the keys to the latrines and the woodshed. The main key must be returned to the leisure centre as soon as possible after the reservation. If the key is lost, the Municipality of Pirkkala reserves the right to charge the changing costs of the locks.

Amenities

The amenities are modest: a small refrigerator with a freezer compartment, a tap, a microwave, a 2-plate stove, a coffee maker, an electric kettle and a CD player. Bring your own tableware and other equipment. Firewood is in the woodshed.

Using the camping centre

- ✓ The party who made the reservation is responsible for ensuring compliance with the terms of use during the reservation. Noise must be kept to a minimum during the quiet hours from 22:00 to 7:00. Be aware of that there is around-the-year housing around the Kranstolppa area.
- ✓ Clean the facilities before departure and bring away all your garbage. The municipality reserves the right to charge any additional cleaning costs.
- ✓ Make sure that the lights are turned off and the doors are locked before you leave.
- ✓ Camping and bringing caravans to the area is prohibited without separate agreement. Campfires or other open fires must not be lighted if the conditions regarding dryness, the wind or other factors are such that there is a clear risk of forest fire, grass fire or other fire. The party who made the reservation is responsible for checking up-to-date warnings.
- ✓ Activities allowed in the area include swimming, beaching, use of the boat ramp and activities that are considered as everyman's rights, such as gathering berries and mushrooms. There's also a beach that can be used at own risk. It is recommended that event organisers collect a cyanobacterial sample if there is a cyanobacteria warning in effect.

- ✓ Any deficiencies and defects observed in the area must be reported to the technical on-call service or the leisure centre's customer service.
- ✓ Smoking in the area is prohibited.
- ✓ If the customer does not comply with these terms of use, their reservation may be cancelled, or they may be banned from reserving the municipality's facilities.
